**BID INSTRUCTION:**

**01.** Quotations will have to be submitted in a SINGLE Bid. The address of the firm submitting the quotation, NIQ No. along with the date and the Officer to whom the quotation is addressed must appear distinctly on sealed covers. Further, on sealed cover, the following are to be written: QUOTATION FOR SUPPLY & INSTALLATION OF EQUIPMENT/WORKSTATION FOR IIIT GUWAHATI.

**NIQ TERMS & CONDITIONS:**

**01. Rates:** The Quotes must be in INR (₹). The bid must mention prices of all items asked for individually and then summed up at last on door delivery basis i.e. Basic Price and other charges such as Packing, Freight, insurance, Installation & commissioning charge, GST etc. as applicable as per **Annexure-II**.

**02. Validity of Quotation:** Quoted rates must be valid for **45 days** from the date of quotation.

**03. Warranty:** The quoted equipment must be Three Year on site comprehensive warranty.

**04. Literature a must:** All the quotations must be supported by the printed technical leaflet/ literature and the specifications mentioned in the quotation must be reflected/ supported by such printed technical leaflet/ literature. The model and specifications quoted should **invariably be highlighted** in the leaflet/literature for easy reference.

**05. Dealership Certificate:** Dealers or Agents quoting on behalf of Manufacturer must enclose valid dealership certificate along with the bid.

**07. Delivery and Installation:**

- a) Time Limit:** Within 30 days from the date of placement of Purchase Order.
- b) Safe Delivery:** All aspects of safe delivery shall be the exclusive responsibility of the vendor. At the destination site, the package will be opened only in the presence of IIIT user/ representative and vendor's representative. The intact condition of the package and the seal/indicators for not being tampered with, shall form the basis for certifying the receipt in good condition.
- c) Insurance:** The supplier is to establish 'All Risk Transit Insurance' coverage till door delivery.
- d) Part Delivery:** Part delivery is not allowed.
- e) Installation:** The items will have to be delivered and installed at IIIT Guwahati, Bongora, Guwahati-781015

**08. Conditional tenders not acceptable:** All the terms and conditions mentioned herein must be strictly adhered to by all the vendors. Conditional tenders shall not be accepted on any ground and shall be rejected straightway. Printed conditions mentioned in the tender bids submitted by vendors will not be binding on IIITG.
