**BID INSTRUCTION:**

**01.** Quotations will have to be submitted in a SINGLE Bid. The address of the firm submitting the quotation, NIQ No. along with the date and the Officer to whom the quotation is addressed must appear distinctly on sealed covers. Further, on sealed cover, the following are to be written: QUOTATION FOR SUPPLY & INSTALLATION OF SUPPLY AND INSTALLATION OF ANSYS POWERARTIST SOFTWARE AND ANSYS REDHAWK SOFTWARE.

**NIQ TERMS & CONDITIONS:**

- 01. Rates:** The Quotes must be in INR (₹). The bid must mention prices of all items asked for individually and then summed up at last on door delivery basis i.e. Basic Price and other charges such as Packing, Freight, insurance, Installation & commissioning charge, GST etc. as applicable as per **Annexure-II**.
- 02. Validity of Quotation:** Quoted rates must be valid for **45 days** from the date of quotation.
- 03. Warranty:** Warranty may be there only on defective media for a maximum period of 15 days.
- 04. Updates and Upgradation:** All software updates must be provided free of cost for 1 year. However, the software and tools updates and upgradation & technical support under this AMC for 1 year.
- 05. Installation and Training:** Due to the ongoing Covid-19 scenario online installation and training will be considered initially but once government allow normalcy the vendor will have to impart two days physical onsite training at IIIT Guwahati.

06. **Literature a must:** All the quotations must be supported by the printed technical leaflet/ literature and the specifications mentioned in the quotation must be reflected/ supported by such printed technical leaflet/ literature. The model and specifications quoted should **invariably be highlighted** in the leaflet/literature for easy reference.

07. **Dealership Certificate:** Dealers or Agents quoting on behalf of Manufacturer must enclose valid dealership certificate along with the bid.

08. **Earnest Money:** Nil

09. **Delivery and Installation:**

a) **Time Limit:** Within 30 days from the date of placement of Purchase Order.

b) **Safe Delivery:** All aspects of safe delivery shall be the exclusive responsibility of the vendor. At the destination site, the package will be opened only in the presence of IIIT user/ representative and vendor's representative. The intact condition of the package and the seal/indicators for not being tampered with, shall form the basis for certifying the receipt in good condition.

c) **Insurance:** The supplier is to establish 'All Risk Transit Insurance' coverage till door delivery.

d) **Part Delivery:** Part delivery is not allowed.

e) **Installation:** The items will have to be delivered and installed at IIIT Guwahati, Bongaigaon,  
Guwahati-781015

10. **Conditional tenders not acceptable:** All the terms and conditions mentioned herein must be strictly adhered to by all the vendors.
